## ORDER

## [UNDER SECTON 144 CRIMINAL PROCEDURE CODE-1973]

- 1. Whereas due to the situation prevailing in the areas under the control of Commissioner of Police. Pimpri Chinchwad, it is apprehended that subversive / antisocial elements may seek hide outs in the residential areas and there is every likehood of breach of peace and disturbance of public tranquility with grave danger to human life and injury to private / public property on that account.
- 2. And whereas, it is necessary that some check should be put on Iandlords / tenants so that terrorist / anti-social elements in the guise of tenants may not cause subversive actvities, riots, affray etc, and that immediate action is necessary for the prevention of the same.
- 3. Now therefore, I, Vinoy Kumar Choubey, Commissioner of Police, Pimpri Chinchwad Executive Magistrate, vide powers conferred upon me u./sec 144 of the criminal procedure Code, 1973 [Act II OF 1974] r/w the Commissioner of Police, Pimpri Chinchwad, Government of Maharashtra, Notification No. PRO. 0918/C.R.325/SPL.-2-In dated 21st September 2018, do hereby order that each landlord/owner/persons dealing in property business of any house/property which falls under the jurisdiction of Pimpri Chinchwad Police Commissioner who has let/sub-let/rent out any accommodation to any person, shall immediately furnish the particulars of the said tenant/tenants online on the citizen portal on www.pcpc.gov.in
- 4. If the person to whom the accommodation is let/sub-let/rented out is a Foreigner, .i.e then the owner and the Foreigner, shall furnish his Name, Nationality, Passport details .i.e, Passport No's, Place and date of issue, validity, Visa details .i.e Visa No., category, Place and date of issue, validity, registration place and reason for stay in the city.
- This order shall come into force with effect from 00.01 hrs of 03.09.2023 till 24.00 hrs of 01.11.2023 for the period of 60 days [both days inclusive] unless withdrawn earlier.
- 6. Any person contravening this order shall be purishable under section 188 of the Indian Penal Code, 1860
- 7. As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. It shall be published for the information of public, through press, and by affixing copies on the Notice Boards of the Police Stations, Divisional ACsP, Zonai DCsP, Municipal Ward offices, and by affixing copies at Tehsil and Ward offices.
